1. All ticket entries must be received by 31 October 2010.
2. Any ticket entries received after 31 October 2010 will be considered as donations.
3. No tickets can be sold to, on behalf of, or for a person under the age of 16 years.
4. If a ticket is sold unknowingly to, on behalf of, or for a person under the age of 16 they will be exempt from the competition and will forfeit their prize.
5. Winners may be required to take part in St Vincent de Paul Society PR and promotional activity.
6. Employees of the St Vincent de Paul Society and their families are ineligible to enter this raffle.
7. The St Vincent de Paul Society is registered with the Gambling Commission to operate this raffle, licence number 000-004662-C-100848-003. This licence is issued under Part 5 of the Gambling Act 2005.
